## 2-Year Health Guarantee Agreement

For Brittany & English Springer Spaniel Puppies

This Health Guarantee is provided by the Breeder to the original purchaser (“Buyer”) for the puppy identified on the sales contract. The purpose of this agreement is to ensure the health, well-being, and responsible ownership of every puppy produced by the Breeder.

---

### **1. General Health at Time of Sale**

The Breeder guarantees that the puppy is in good health at the time of sale.

Prior to placement, the puppy will have:

- Age-appropriate vaccinations
  - Routine deworming
- A veterinary wellness examination
- Health records provided to the Buyer

The Buyer has **72 hours** from the date of possession to have the puppy examined by a licensed veterinarian. Failure to complete this examination within 72 hours renders this guarantee void.

If the examining veterinarian determines the puppy has a serious contagious illness or life-threatening condition that existed prior to delivery, the Buyer must notify the Breeder immediately and provide written veterinary documentation.

The Breeder reserves the right to request a second opinion from a veterinarian of the Breeder's choosing.

## **2. Two-Year Genetic Health Guarantee**

The Breeder guarantees the puppy against hereditary or congenital defects that significantly affect the dog's quality of life for a period of **two (2) years** from the puppy's date of birth.

Covered conditions may include, but are not limited to:

- Severe hip dysplasia
- Hereditary eye disorders
- Congenital heart defects
- Epilepsy with genetic origin
- Other life-altering hereditary diseases confirmed by veterinary specialists

To qualify under this guarantee:

1. The condition must be diagnosed by a licensed veterinarian and supported by documentation from an appropriate veterinary specialist.
2. The condition must be proven to be hereditary or congenital in nature.

3. Copies of all veterinary records, diagnostic testing, and specialist findings must be provided to the Breeder.

If a qualifying hereditary condition is confirmed within the guarantee period, the Breeder will provide one of the following remedies at the Breeder's discretion:

- A replacement puppy from a future litter of equal value, OR
- Partial reimbursement of the original purchase price toward veterinary treatment

Under no circumstances shall the Breeder be responsible for veterinary expenses exceeding the original purchase price of the puppy.

### **3. Conditions That Void This Guarantee**

This guarantee becomes null and void if any of the following occur:

- The puppy is neglected, abused, or improperly cared for
- The puppy is allowed to become overweight or severely underweight
- Injury caused by accidents, rough handling, or environmental hazards
  - Failure to provide routine veterinary care and vaccinations
    - Failure to administer proper parasite prevention
    - Breeding the dog prior to recommended health testing
- The puppy is sold, transferred, or surrendered to another owner
- The dog is used for illegal activity or improper housing conditions

This guarantee does not cover:

- Minor, non-life-threatening conditions
- Allergies, skin sensitivities, or environmental reactions
  - Internal or external parasites after delivery

- Stress-related illnesses caused by transport or transition
  - Common puppy illnesses such as coccidia or giardia unless life-threatening
  - Ear infections, minor bite alignment issues, or retained baby teeth
  - Injuries or illnesses caused by poor nutrition or improper exercise

#### **4. Buyer Responsibilities**

The Buyer agrees to provide:

- Proper nutrition and fresh water
  - Routine veterinary care
  - Safe and humane housing
- Appropriate exercise and socialization
- Preventative care including vaccines and parasite control

The Buyer understands that Brittanys and English Springer Spaniels are active sporting breeds requiring regular physical and mental stimulation.

---

#### **5. Return Policy**

If at any point during the dog's lifetime the Buyer is unable to keep the dog, the Breeder must be contacted immediately.

The dog may not be surrendered to a shelter, rescue, pet store, or third party without first notifying the Breeder. The Breeder will assist in rehoming or may choose to take the dog back.

No refunds are guaranteed for returned dogs unless otherwise agreed in writing.

## **6. Limitation of Liability**

The Breeder makes no guarantees regarding:

- Adult size or weight
  - Show quality
  - Breeding potential
- Temperament beyond normal breed standards
  - Training performance or hunting ability

While every effort is made to produce healthy, sound puppies with excellent temperaments, genetics and environmental factors can influence long-term development.

By purchasing this puppy, the Buyer acknowledges that they have read, understood, and agreed to all terms outlined in this Health Guarantee Agreement.
